PRIVACY POLICY AND DISCLAIMERS

COMMITMENT TO PRIVACY

Your privacy is important. To better protect your privacy, Realizing Self, LLC (the “Company”) provides this notice explaining its online information practices and the choices you can make about the way your information is collected and used. To make this notice easy to find, this Privacy Policy is available on the Company’s website (TheRachelStarr.com, the “Website”). This Privacy Policy applies to all information collected or submitted on the Website. As noted below, please be aware that Company may change this Privacy Policy in the future and it is your obligation to review this Privacy Policy from time to time and the effective date listed with it.

WEBSITE USERS MUST BE 18 YEARS OLD

By accessing and using the Company’s website, you affirmatively acknowledge that you are **AT LEAST EIGHTEEN (18) YEARS OLD**. No one under the age of 18 years old is authorized to view or subscribe to the website.

MEMBERS ONLY SITE/ADULTS ONLY SERVICE

The Company’ website may have a Members Only Section, which is an adult site that expressly and strictly limits its membership to adults over the age of eighteen (18) years. This Website does not knowingly seek or collect any personal information or data from persons under the age of eighteen (18). All persons under the age of eighteen (18) are strictly prohibited from accessing or viewing the Members Only Content on the website site without exception. If you are under the age of eighteen (18) and/or under the age of majority in the jurisdiction you reside and from which you access the website, then your account will be terminated without notice or delay.

INFORMATION COLLECTED FROM YOU

Any user that joins/signs up as a Member of the website will be required to provide personal information as well as demographic information which may include the Member’s first and last names, physical address, billing address, e-mail address, zip code, country, username, and password. The website collects any and all such information and includes it in a Member database. Disclosures of Information

Your name, physical address, phone number and password are considered confidential and private to you. However, all information you provide to the Company may be shared with other third parties as necessary fulfill technical requirement or to comply with applicable law, to cooperate with law enforcement and the court system. You consent to the Company's use of your information in the manner described in this Privacy Policy by accessing and using the Website.

Financial Information

All credit card transactions and such are processed with industry standard encryption through third party processors. Said processors only use your information for that purpose. Security of Information
